OPENING DECLARATION

RECORD BEGINS HERE

This book opens in **SILENCE** – not **absence**, but **pressure**.

The kind of **SILENCE** that follows unanswered filings.

SILENCE that hides inside of sealed records, missing acknowledgments, and official non-responses.

That **SILENCE** that pretends nothing happened while everything continues to happen.

SILENCE is a weapon.

Misunderstood, it is used against you.

Understood, it can be turned back on the system that relies on it.

This book exists to teach that distinction.

I am not here to convince you of anything.

I am not here to beg, perform pain, prove innocence, or recap **every** fact.

I am here to document **methods**, **patterns**, and **techniques** – drawn from living case examples that remain publicly traceable – so that **BLACK men** and **BLACK families** can recognize hostile systems *before* those systems close around them.

This is **not sentiment**.

This is **preparation**.

PENNSYLVANIA ON TRIAL

Pennsylvania is *often* framed as the **backbone of American ideals** – the *birthplace of founding documents*, the *land of “brotherly love.”*

This **record** places something else on trial:

Not mythology. **Not** abstractions... **Conduct.**

What happens when **officials** manipulate documentation, defer accountability, and allow contradictions to sit unaddressed – *year after year* – while lives are altered underneath that **silence**? What happens when the record speaks, **but no one answers**?

This book **does not** accuse.
It **archives**.

I write as an **archivist**.
A **sentinel**.
A **chronicler of the record**.

WHAT “SILENCE” MEANS HERE

Silence in this book is **not metaphor**.

It appears in **three concrete forms**:

1. **Institutional Silence:**

If you deny that, **you deny proximity to your own people**.

You **do not** have to **like me**.

You **only** have to **read what was written** – and **what was done**.

THE READER'S ROLE: WITNESS, NOT SPECTATOR

A **spectator** buys a ticket and *passively* watches... They may even buy a jersey, or two... A **witness** is close enough to absorb the impact.

If you are reading this, you are not here for **entertainment**. You are here because you have **lived this**, stood next to **someone** who has, **or** sensed the pattern **before** it *fully revealed itself*...

{SPOILER ALERT} Once you become a **witness**, you **do not** return to **innocence**.

This book is **not** meant to be **consumed all at once**. It is meant to be **returned to** – when the rhythm shifts, when the harmony breaks, when something feels off but **cannot** yet be named.

OATH OF THE WITNESS

Before you proceed, understand your **role**.

You **are not** being asked to **agree**.

You **are** being asked to **observe** *honestly*.

To notice **contradictions**. To track **omissions**.

To **remember** what institutions hope you will **forget**.

Silently, to yourself:

I **swear** to uphold the principles that protect *my* being from destruction.

I **do not** need permission to resist that which harms me.

I **trust** *my* perception. I **document** what I see. I **remain** disciplined *under* provocation.

Race is **not** hidden here.

Black people were once *legally* defined as **three-fifths human**.

“Three-fifths: Man – and the other two-fifths: Godly (1/5th God; 1/5th Goddess)” ~ *An original quote by Lewdo*

This book **does not** call for racial grievance...

It refuses **racial amnesia**.

You are **Black** in a system that sees you as such – **whether you acknowledge it or not**.

Ignoring that reality **does not** neutralize it.

And, if we are honest; the word “**ignorant**” derives from “**ignore...**”

Do Not become ignorant to your own people!!

WHAT LIES AHEAD

Inside this book you will encounter:

- **legal proceedings** without resolution
- **administrative actions** without accountability
- **family-court spillover**
- **retaliation patterns**
- **concealment**
- **intimidation**
- **contradictions** preserved in **public record**

This is one man, **Lewdo's**, story, and a template of institutional behavior others will recognize...
Immediately.

A **systemic** war was brought to my door to make me crumble...
Instead, it was **documented**... **Preserved**, inside of its **original packaging** and serviced back to the **original owners**.

COST – WITHOUT DRAMA

This **record** costs **time**, **money** and **energy**.

The system fights communities *using* **community resources**.
It exhausts individuals by design.

I am not a hero (that's a **sandwich**).
Everyone must save themselves.

This book exists so fewer people have to learn these lessons alone.

HOW TO READ THIS BOOK

THIS IS NOT A WORK OF FICTION... IT IS A DOCUMENTARY MEMOIR...

The events described throughout this book are based upon actual experiences, documented records, public filings, and legal proceedings. Although the focus of this work is the conduct of systems, institutions, and ideas rather than individual personalities, the underlying events arose from **REAL CASES** and **REAL RECORDS**. The relevant proceedings are identified below for **readers who wish to examine the record for themselves**:

Readers are encouraged to review the public record and reach their own conclusions.

This book is written *differently* than most books.

It was **never** intended to be read as a **collection** of opinions, arguments, **or** memories. It was designed and formatted as a **FIELD MANUAL**.

A **FIELD MANUAL** serves a different purpose than a **traditional book**.

Traditional books are often read **once**.

FIELD MANUALS are studied, referenced, revisited, **and** applied.

The **objective** is **not** merely to **finish** the book.

The **objective** is to understand the **patterns** within it.

EMOTIONS AS CHARACTERS

Throughout this book, **emotions** are *often* presented as if they were **people**, **personalities**, **archetypes**, *or* **visitors**.

This is **INTENTIONAL**.

In my 40+ years on earth, I witnessed many people spend their lives *either obeying emotions, strictly, or suppressing them...* Both approaches create **problems**.

I learned a different lesson as a child:

One day I came storming into the house, panicking as I was being chased by a swarm of bees. The outcome wasn't as serious as the fright was.

My **Father** looked at me and asked:

"Why are you running up in here, like a madman, along with **FEAR**, like it's your **best friend**?"
That sentence stayed with me.

Years later, I realized something important:

FEAR is **not my enemy**.

But **FEAR** is **not my best friend** either.

FEAR is a **watchman... a guardian... a lookout** standing on the porch.

When **DANGER** approaches, **FEAR** alerts me.

For that, I am **GRATEFUL...**

But **FEAR** is not allowed to live in the house.

The *same principle* applies to *every EMOTION...*

ANGER has a purpose.

PRIDE has a purpose.

GRIEF has a purpose.

SHAME has a purpose.

COURAGE has a purpose.

Each emotion carries information.

None deserve **complete** authority.

When emotions appear throughout this book in **CAPITAL LETTERS**, they are often being treated as **characters, advisors, visitors, guardians, deceivers, teachers, or archetypes**.

The **goal** is to help readers **separate themselves** from their emotions **long enough to learn from them...** An **emotion** should be **consulted**. It should **not** become the **dictator**.

WHY CERTAIN WORDS ARE CAPITALIZED

This manuscript uses **TYPOGRAPHY** *intentionally*.

Words *may* appear:

- Capitalized
- BOLD
- Italicized
- UPPERCASE

These **CHOICES** are *rarely* **decorative**.

They **function** as **SIGNALS**.

The same way a **military field manual** uses **symbols**, **warnings**, and **visual markers**, this book uses **typography** to identify ideas that deserve special attention.

Certain **words** appear *repeatedly* because certain **patterns** appear *repeatedly*.

The **formatting** is designed to **help readers** *quickly* **locate concepts** when returning to the book later. Because this book was written to be **referenced**, **not** *merely read*.

WHY SILENCE APPEARS IN UPPERCASE

One **word** appears throughout this manuscript more than almost any other:

SILENCE.

This is **intentional**.

Many **books** teach people how to **speak**.

This **book** is *equally* interested in teaching people how to **observe**.

How to **listen**. How to **recognize** what is **absent**, **withheld**, or **never** receives an **answer**.

SILENCE appears *repeatedly* because **SILENCE** is **not** empty.

SILENCE reveals, conceals **and** protects.

SILENCE punishes, preserves **and** communicates.

Individuals use silence. **Families** use silence. **Communities** use silence. **Institutions** use silence. **Governments** use silence. **Systems** often speaks through **SILENCE** long before it speaks through words.

If there is a single recurring teacher hidden throughout this book, it is **SILENCE**.
Pay attention whenever it **appears**.
It *rarely* arrives *without* **purpose**.

THE FOUR MIRRORS

Each chapter concludes with a section called:

THE FOUR MIRRORS

The Four Mirrors are **not summaries**. They are **translations**. *Every lesson* can be viewed through **four different lenses**:

ART – The Mirror of PERSPECTIVE

ART asks:

How is this being framed? What am I being shown? What am I not being shown? How does perspective influence interpretation? **Art** teaches that people rarely react to reality directly. They react to the frame surrounding reality.

MUSIC – The Mirror of HARMONY

MUSIC asks:

What patterns repeat? What rhythms exist beneath the surface? What sounds are working together? What sounds are creating tension? **Music** teaches that systems often reveal themselves through recurring patterns long before they reveal themselves through individual events.

WAR – The Mirror of STRATEGY

WAR asks:

What incentives are operating? What positions are being established? Who benefits? Who loses leverage? What is the long game? **War** teaches that outcomes are often determined long before the final conflict becomes visible.

NATURE – The Mirror of REALITY

NATURE asks:

What happens regardless of opinion? What patterns repeat throughout life? What consequences emerge naturally? What truths exist whether we acknowledge them or not? **Nature** serves as the final mirror because **reality** ultimately outranks ideology, preference, and narrative. **Reality** remains... Whether we agree with it or not.

A FINAL NOTE

You are **not** required to **agree** with anything **written** here.

You are **not** required to **reach** the same **conclusions**.

You are **not** required to **choose** a **side**.

You are **only** asked to **observe**.

Notice the **patterns**. Study the **timelines**. Compare **words** to **behavior**. Compare **promises** to **outcomes**. Pay attention to what is **present**. Pay attention to what is **missing**. And above all, pay attention to **repetition**. Because **isolated events** can be misunderstood... **Patterns** *rarely* are.

PART IV

WHEN SYSTEMS BEGIN TO COORDINATE

Thesis:

Separate actors **do not** need a meeting to move as one.
They **only** need **shared** incentives, **shared** silence, and a **shared** threat...

COORDINATION begins the moment the system decides you are **unmanageable**.

I. The Shift: From Interference to Organism

There is a difference between **CONFLICT** and **PATTERN**.
CONFLICT is friction between two parties.
PATTERN is when multiple hands move in rhythm without introduction.

PART IV begins long before **December 25, 2024**. Traces back to **2007**. Matured around **2015**...
But the most visible eruption occurred on **Christmas Day, 2024 – 9:18 PM** –
During an *alleged ex parte* proceeding on a **federal holiday, after court hours**...
A time when *ordinary people* were **opening gifts, gathering with family**...
And **believing** government buildings **were closed**...

Relief was **denied**... The **case** was marked **closed**.
Yet the case (Case No. 2024-MI-000581) remains **open** to this day (**June 19, 2026**).
Within **hours, two (2) Protection From Abuse orders** materialized:

1. **2024-FC-002653-12A** (Both cases are “**non-docketed**” to this day: **June 19, 2026**)...
2. **2020-FC-001144-12A** (Opened **December “2024”** with a “**2020**” “**case identifier**”)
(2020-FC-001144-12A was **created** to alter its original case: 2020-FC-001144-03)...

Neither properly logged... Both enforced...

Both stamped by officials across departments... Multiple judges' signatures.

Multiple offices validating documents that did not exist in the system (at any time)...

Not COINCIDENCE... (I CONTEMPORANEOUSLY contacted EACH office involved)...

COINCIDENCE is divine timing... COORDINATION is human engineering...

COINCIDENCE is rain... COORDINATION is irrigation...

One falls from HEAVEN... The other is built by MEN.

II. The First Alignment Moment

December 26, 2024, 7:11 PM: The door knock.

York County Sheriff's Deputies arrived stating they "had" to remove the child...

"Had..." Not "may..." Not "pending..." Not "subject to hearing..." "Had."

When asked why we were not summoned to court – if officers could arrive at our home... Why not notify us of a hearing? – the answer redirected us to "the courts..."

When asked how to sue, one officer visibly reacted... A literal "double take." A pause...

That was the *first fracture* in the performance:

(1) "Committed to Excellence" ~ York County, Pennsylvania (Slogan)

(2) "Let Freedom Ring" ~ Pennsylvania state (Slogan)

Unless these slogans apply outside of its local, Black Community, ONLY...

Evidence proves these slogans fail drastically under the test of any endurance...

Especially within the York County of Pennsylvania's Black Community.

(SIDE NOTE: As expected... to this day, I have been denied any Discovery or Disposition, to recover said police footage; even after submitting complementary footage to court.)

From that moment forward, something was clear: *Separate offices already knew the script.*

III. The Alignment Signature

COORDINATION has a sound.

It sounds like:

- “We’re just following procedure.”
- “That’s not our department.”
- “Call them.”
- “It’s in the system – you’re just not seeing it.”

And when you ask **where to see it?** “It’s **CONFIDENTIAL**.”

The **alignment signature** is simple:

Repeated **phrases**. Synchronized **ignorance**. Uniform **refusal**. Time-compressed **decisions**.
Different faces... Same posture.

IV. The Voltron Effect

Individually, each actor is **small**:

A Clerk... Deputy... Paralegal... Judge... Private citizen... Law firm.

Alone, they are **manageable**... **Together**, they form a machine.

Like minions assembling **into one towering figure** – not because they were summoned...

Because they recognized a common interest.

People **who supposedly know nothing about one another**...

Suddenly behaving as though they **attended the same briefing**...

This is the **Voltron effect of institutions**:

No **meeting** required. Just **alignment of incentives**.

Shared **LIABILITY** creates shared **LOYALTY**.

V. Mapping the Network (Structure Without Accusation)

Primary Actors (Direct Power):

- York County Judicial Center
- York County Prothonotary
- York County Sheriff’s Department
- York County Administration
- York County Board of Commissioners
- County of York
- U.S. District Court clerks and assigned judges

Secondary Actors (Reinforcing Power):

- MPL Law Firm
- Associated attorney and paralegal
- Sheriff & Deputies
- Court personnel

Tertiary Actors (Narrative Reinforcement):

- Private citizens
- Community silence
- Institutional reputation shields

The Gatekeepers were clerks.

The Messengers were law enforcement.

The Validators were judges and *official stamps*.

A document stamped becomes reality – even if never entered into the system...

These Non-Docketed Instruments are in Violation of Due Process & Article III Supremacy.

VI. Timing Tells

COORDINATION reveals *itself* through SEQUENCE.

December 25, 2024 – alleged ex parte denial – 9:18 PM.

December 26, 2024 – enforcement of two (2) challenged PFAs **not in ANY system**.

January 21, 2025 – unofficial emailed notice for a hearing **not in ANY system**.

January 22, 2025 – finalization stamped for a hearing **not in ANY system**.

January 23, 2025 – weapons confiscated (through **handwritten**, *official paperwork*).

March 11, 2025 – two federal cases opened:

1:25-cv-000446 (**private citizens / private attorneys**)

1:25-cv-000447 (**county / county agencies**)

Then came the REASSIGNMENT ANOMALY:

A magistrate judge *verbally reassigned without* proper docket authorization.

In contradiction to the court's own IOP (**Internal Operating Procedure**).

Floating docket entry. **No signature. Initials only.**

(in **between** – Docs. 56 & 57; Case No. 1:25-cv-000446).

(in **between** – Docs. 58 & 59; Case No. 1:25-cv-000447).

Later, the Court *of Appeals* vacated ALL three *final judgments* (Case No. 25-2432)...

VACATED...

For REPRESENTED parties (attorneys), that is RARE.

For PRO SE litigants, *statistically* MICROSCOPIC.

THREE out of THREE.

If additional vacates occur in 26-1138 and 26-1167, the pattern escalates.

That is not EGO... That is MATHEMATICAL ANOMALY.

BLACK SWAN territory (thus the “publishing”).

VII. The Denial Architecture

INFORMATION became LABYRINTHINE.

Call this office... No, call that office... We did not say that... File here... Wait for the notice...

That’s not our jurisdiction... We don’t handle that... Call this office...

The RUNAROUND is not DISORGANIZATION... It is DELAY ARCHITECTURE...

(operating, *exactly*, the way in *which* it was designed to).

The MAZE exhausts... Meanwhile, ENFORCEMENT continues:

Instructions change... Referrals without resolution... Paperwork “lost.”

Paperwork “altered” (by clerks – Docs. 196-198; Case No. 1:25-cv-000447).

SILENCE becomes PROCEDURAL CAMOUFLAGE.

VIII. Narrative Manufacturing

The non-official-official story: Unfit. Abusive. Misconduct...

Fifteen years of uninterrupted caregiving erased.

The father in question: *publicly charged with solicitation of a minor* – reduced through plea...
(Case No. CP-67-CR-0007883-2014).

Yet the projection redirected toward us... The LIE survives when:

- Documentation never enters the system.
- Contradictions remain uncorrected.
- Clerks alter filings.
- Metadata is ignored.
- Questions are reframed as “frivolous.” “Prolix.” “Verbose.” “Meritless.”

When **LANGUAGE** fails to defeat you, **LABELS** attempt to.

IX. Silence as Weapon

December 25, 2024 → March 11, 2025.

The **SYSTEM** went **SILENT**... We **went** quieter.

No public accusation... No emotional spectacle... **Documented**.

X. What Coordination Does to a Human

SLEEP unchanged... **DISCIPLINE** intact... **TRUST**? Never misplaced:

I was **BORN** into systems... **RAISED** under **military** structure... **TRAINED** in **hierarchy**...

Systems **do not** love you... They **protect** themselves.

Pressure **does not** burst diamonds... It **clarifies** them.

XI. Scenes of Alignment

Scene ONE – The Door Knock

The officer says “**had**.”

The paperwork contradicts officer ‘**Do-The-Right-Thing**.’

Her eyes flicker when asked about suing.

The script is bigger than her.

Scene TWO – The Clerk Gate

Documents altered... Entries floating without number.

Reassignment without written authority.

The gate is not the judge – it is the clerk.

Scene THREE – The Script Echo

Different offices... Same language.

“We’ll look into it...” “We’re just following procedure.”

Call logs repeat like chorus lines.

Scene FOUR – The Contradiction

Ex parte meeting... 9:18 PM Christmas.

Altered names on official paperwork.

Metadata 22 months advanced.

Relief denied. Case closed.

Case still open 540+ days later.

Two PFAs appear hours after denial.

Stamps at 7 AM before open hours.

The CONTRADICTION is **not** SUBTLE... It is STRUCTURAL.

Scene FIVE – The Silence

When they **stopped responding**, I knew the **leverage shifted**.

Silence means **containment** strategy.

So I stayed silent *longer*.

(SIDE NOTE: The York County Judicial Center, in person, **January 7, 2025**, *officially stated that neither case existed*. There were **no cases actively** involving **myself**, nor **Monique**; and **neither of these cases exists within their databases**, as the record verifies... yet, and still, **enforcements** occur to this *very day – Juneteenth – June 19, 2026*).

XII. The Human Cost

The CHILD loses PARENTAL bridge...

The SYSTEM gains PROCEDURAL insulation.

PRIVATE ACTORS believe they gained ADVANTAGE...

In REALITY, they inherited INSTABILITY.

REPUTATION DAMAGE inverted into REPUTATIONAL ASCENSION.

Attempts to BURY turned into AMPLIFICATION.

(The LOUDEST Silence)

XIII. The Lesson

COORDINATION is rarely **loud**... It **looks** like:

- Plausible deniability.
- Fragmented authority.
- Distributed responsibility.
- Administrative delay.

VIOLENCE draws ATTENTION.

PLAUSIBLE DENIABILITY sustains HARM.

XIV. Warning to Families

Early indicators:

- Identical phrasing across offices.
- Time-compressed decisions after you assert rights.
- Referrals that circle back.
- Policies invoked but never shown.
- Outcomes communicated before hearings occur.

When **separate actors** begin defending **one another's** blind spots, **the organism** has formed.

Especially if you are **Black, articulate, and unafraid of paperwork.**

The **system** will **test** whether you **understand** its language (the Rosetta Stone test).

XV. Coordination Defined

HARM becomes INSTITUTIONAL when **multiple ACTORS** move in **ALIGNMENT** *without ever saying so out loud*...

It COST:

- Trust in procedural fairness.
- Time.
- Peace.
- Reputation (**temporarily**).

It TAUGHT:

- **Black people** still **CANNOT & SHOULD NOT** trust the system.
- Documentation outlives denial.
- Silence can be strategic.
- Vacated judgments expose structural fractures.
- Fraud and conspiracy vitiate everything. (or is that just a “court” slogan)
- Systems fear exposure more than accusation.

And **most** importantly:

Since **BATMAN** refused to arrive, *either...*

He **does not** exist, *or...* He **does not** protect **Black people** from “official” corruption.

Either way, *he* revoked *his* “**BLACK**” Card... *he* is **NOT** *the* “**Night...**”

Learn to **stand**, *for* **SELF**... There are **NO** **HEROs** courageous enough to save **Black People**.

THE FOUR MIRRORS

ART – MOSAIC

An elder craftsman spends years assembling a mosaic...

Each stone appears insignificant on its own:

A blue stone... A black stone... A red stone... A white stone.

No single piece explains the picture...

Only when a traveler steps back does the image emerge.

Wisdom often works the same way: A single event may appear random...

A single decision may appear isolated... A single refusal may appear harmless...

But when enough pieces begin forming the same image, the picture becomes difficult to ignore.

My ancestors teach: Do not stare only at the stones... Study the pattern they create together.

MUSIC – THE REVERB CHAMBER

A singer speaks once... Yet the listener hears the voice many times.

Not because multiple people are speaking... Because the room keeps repeating the sound.

The reverb creates the illusion of many voices when the source may be singular.

Systems often behave similarly: One idea enters the chamber...

One assumption enters the chamber... One narrative enters the chamber...

Soon it appears everywhere...

Learn to distinguish between an original voice and the room repeating it.

WAR – THE KING'S COURT

A king rarely issues every command personally... He does not need to:
The advisors understand the kingdom... The governors understand the advisors...
The magistrates understand the governors... The guards understand the magistrates.
By the time an order reaches the outer provinces, the king may never have spoken a word...
Yet the kingdom still moves in one direction...
REMEMBER: The most powerful kingdoms are not governed by commands...
They are governed by expectations.
“Keep juggling... Fire-hoops *are* the *only* reward *for* the jester.” ~ **Lewdo**

NATURE – THE EIGHTH PLAGUE

A farmer notices a few locusts in the field... No alarm is raised... A few insects are normal.
Then a few become dozens... Dozens become hundreds... Hundreds become thousands.
Eventually the sky darkens... The farmer understands something the children do not:
The danger was never the individual locust...
The danger was the moment separate movements became a swarm.
No single insect intended to consume the harvest... Yet the harvest disappears all the same.
Nature teaches a difficult lesson:
Some of the most destructive forces in existence emerge not from a single powerful actor...
But from countless small actors moving in the same direction...
Wise people study the swarm long before they study the damage.

LEWDO's professional experiences have carried him through creative spaces, educational spaces, community spaces, studios, galleries, and countless conversations where stories often lived longer than official records.

Throughout LEWDO's life, he has operated according to a **SIMPLE PRINCIPLE**:

When **POWER** speaks, **LISTEN**.

When **PEOPLE** speak, **LISTEN**.

When **RECORDS** speak, **LISTEN** *even CLOSER*.

That **PRINCIPLE** *eventually* **EVOLVED** into a personal **DISCIPLINE** that would become **CENTRAL** to this **BOOK: DOCUMENTATION**.
